



## **ITEC Entry Level 3 Award in an Introduction to the Hair and Beauty Sector QAN 500/6099/5 Specification**

### **Aims and Objectives**

The main aim of the ITEC Entry Level 3 Award in an Introduction to the Hair and Beauty Sector is to enable Learners to make use of skills, knowledge and understanding to carry out structured tasks and activities in familiar contexts with appropriate guidance where needed. The qualification is suitable for pre 16 Learners and/or Learners aged 16 and over and is a sound platform into further learning at Level 1 and Level 2

### **Content**

This qualification is for Learners who want to progress to further learning in order to work in a Beauty Salon or Spa. The qualification consists of 2 mandatory units and 1 optional unit with a total of 70 hours of Guided Learning (GL) to achieve the full qualification

The main skills the Learner will learn to perform are:

- Presenting a professional image in a salon – to include communicating in a professional manner, wearing appropriate attire and maintaining personal hygiene

The Learner will also learn about the different occupational roles and career opportunities within the Hair and Beauty Sector, different types of salons and the main Hair and Beauty Services available in a salon

The Learner will also be able to choose from a range of optional units to complete the qualification, for example:

- Skincare
- Hand Care
- Create an Image using Colour for the Hair and Beauty Sector
- Shampoo and Conditioning
- Hair Plaiting OR Plaiting and Twisting Hair
- Nail Art Application
- Themed Face Painting
- Basic Make-up Application
- Styling Women's Hair
- Styling Men's Hair

It also provides:

- Opportunities for Learners to focus on the development of their wider skills in a Hair and Beauty setting, such as communicating with clients and working with others
- Opportunities for Learners to develop a range of skills, techniques, personal qualities and attitudes essential to carrying out structured tasks and activities in the Hair or Beauty Salon

## Why Choose the ITEC Entry Level 3 Award in an Introduction to the Hair and Beauty Sectors?

1. This Qualification combines a range of skills and knowledge for the Learner to progress to further training and development and to carry out structured tasks and activities under guidance in a Hair or Beauty Salon setting at Entry Level 3. This is the only ITEC qualification in an Introduction to the Hair and Beauty Sectors at Entry Level 3
2. This Qualification is listed in the Ofqual Register of Qualifications
3. Learners may progress on to the ITEC Level 1 Diploma in Beauty Therapy, the ITEC Level 2 Diploma for Beauty Specialists, the ITEC Level 2 Diploma in Beauty Therapy Treatments, the ITEC Level 2 Apprenticeship in Beauty Therapy, the ITEC Level 1 Diploma in Hairdressing, the ITEC Level 2 Diploma in Hairdressing, the ITEC Level 2 Diploma in Hairdressing and Barbering or the ITEC Level 2 Apprenticeship in Hairdressing
4. This qualification does not form part of an Apprenticeship

## Guided Learning (GL)

Guided Learning is the 'activity of a Learner in being taught or instructed by – or otherwise participating in education or training under the immediate guidance or supervision of – a Lecturer, Supervisor, Tutor or other appropriate provider of education or training'. This includes 'the activity of being assessed if the assessment takes place under the immediate guidance or supervision of a Lecturer, Supervisor, Tutor or other appropriate provider of education or training'

## Total Qualification Time (TQT)

Total Qualification Time is the number of notional hours which represents an estimate of the total amount of time that could reasonably be expected to be required, in order for a Learner to achieve and demonstrate the achievement of the level of attainment necessary for the award of the qualification

## Total Credit Value

The total Credit Value for the qualification is equal to one tenth of the Total Qualification Time rounded to the nearest whole number

This qualification will be internally and externally assessed using a range of assessment methods as set out in the table below:-

The overall qualification is graded Pass
