



ITEC Level 1 Diploma in Hairdressing QAN 600/1789/2 Specification

Aims and Objectives

The main aim of the ITEC Level 1 Diploma in Hairdressing is to enable Learners to gain the necessary practical skills and knowledge required by the Hairdressing Industry. The qualification is suitable for Learners aged 16 and over and is designed to provide occupational competence at Level 1. It also provides a sound platform into further learning at Level 2

Content

This qualification is for Learners who want to work within the Hairdressing Industry. The qualification consists of 11 mandatory units plus a selection of optional units covering a minimum of 60 hours of guided learning (GL). A minimum of 340 hours of guided learning are required to achieve the full qualification

The main skills the Learner will perform are:

- Shampoo and Condition Hair - how to massage the hair and scalp correctly to cleanse, condition and treat the client's hair
- Styling Women's Hair - develop basic styling techniques and recognition of key influencing factors associated with styling
- Colour Hair Using Temporary Colours - includes developing a range of application skills for a variety of different products and the effects that can be created by correct use
- Dressing Hair - develop long Hairdressing skills to create a variety of looks, including setting and hair-up

The Learner will also develop knowledge of related health and safety, client care and communication skills which are essential to work and be successful in the Hairdressing Industry

The Learner will also be able to choose from a range of optional units to complete the qualification, for example:

- Hair Plaiting
- Plaiting and Twisting Hair
- Styling Men's Hair
- Provide Scalp Massage
- Style and Finish African Type Hair
- Promote Products and Services to Clients in a Salon

This qualification also provides:

- The related knowledge and understanding required to perform the Hairdressing skills outlined above
- Opportunities for Learners to focus on the development of their wider skills in a Hairdressing setting such as communicating with clients, working with others and problem solving
- Opportunities for Learners to develop a range of skills, techniques, personal qualities and attitudes essential for successful performance in employment in the Hairdressing Industry

Why Choose the ITEC Level 1 Diploma in Hairdressing?

1. This qualification combines the full range of skills and knowledge for the Learner seeking progression to occupational competence at Level 2
2. This Qualification is listed in the Ofqual Register of Qualifications
3. This qualification contains all of the skills and knowledge required for employability at Level 1
4. Learners may progress onto the ITEC Level 2 Diploma in Hairdressing 501/2254/X, an Apprenticeship at Level 2
5. This qualification does not form part of an Apprenticeship
6. This qualification is recognised by all relevant professional bodies within the Hairdressing Industry for membership and insurance purposes at Level 1

Guided Learning (GL)

Guided Learning is 'the activity of a Learner in being taught or instructed by – or otherwise participating in education or training under the immediate guidance or supervision of – a Lecturer, Supervisor, Tutor or other appropriate provider of education or training'. This includes 'the activity of being assessed if the assessment takes place under the immediate guidance or supervision of a Lecturer, Supervisor, Tutor or other appropriate provider of education or training'

Total Qualification Time (TQT)

Total Qualification Time is the number of notional hours which represents an estimate of the total amount of time that could reasonably be expected to be required in order for a Learner to achieve and demonstrate the achievement of the level of attainment necessary for the award of the qualification

Total Qualification Credit Value

The total Credit Value for the qualification is equal to one tenth of the Total Qualification Time rounded to the nearest whole number.

Grading of the Qualification

All assessment tasks required for each unit of the qualification (detailed in tables 1 and 2 of the specification) must be completed and awarded a Pass mark before the complete qualification can be certificated

The overall qualification is graded - Pass - 60% - 74%, Merit - 75% - 89%, Distinction – 90%-100%. This is formed by the aggregate of the multiple-choice questions

Controlled Assessment

All theory tests must be conducted in a controlled environment and follow the procedures defined by ITEC [here](#). The theory tests will be set and marked by ITEC

Failure to operate ITEC Examinations as documented in the ITEC policies and guidance notes may result in sanction(s) against the Centre e.g., withdrawal by ITEC for a particular qualification and/or withdrawal of ITEC recognition from the Centre due to maladministration and/or malpractice. Recommended Prior Learning

It is recommended that Learners have achieved a level of education equivalent to five GCSEs at grades A*-C prior to commencing the ITEC Level 1 Diploma in Hairdressing; however, exemptions may be made for adult returners with experience of the workplace

Once Learners have achieved the ITEC Level 1 Diploma in Hairdressing they may progress on to other ITEC or equivalent qualifications at Level 2, for example:

- Level 2 Diploma in Hairdressing
- Level 2 Apprenticeship in Hairdressing
