



ITEC Level 2 Certificate in Barbering QAN 500/9366/6 Learner Guidance Notes

General Advice

1. Requirements for Undertaking this Qualification

ITEC recommend that you should have achieved a level of education equivalent to five GCSEs at grade A*-C or Level 1 Diploma qualification in Hairdressing prior to commencing the ITEC Level 2 Certificate in Barbering; however your Centre may make exemptions for adult returners with experience of the workplace

2. Structure of the Qualification, Guided Learning (GL)

The ITEC Level 2 Certificate in Barbering is comprised of 6 mandatory units with a total of 196 hours of Guided Learning (GL) and a selection of optional units covering a minimum of 43 hours of Guided Learning (GL) must also be completed in order to achieve the full qualification. However, you will also be required to complete further study and generate evidence of your learning in your own time. This is known as Total Qualification Time (TQT), please see Table 1 and 2

3. Grading of the Qualification

All assessment tasks required for each unit of the qualification (detailed in Table 1 above) must be completed and awarded a Pass mark before the full qualification can be certificated

The overall qualification is graded - Pass - 60% - 74%, Merit - 75% - 89%, Distinction – 90%-100%. This is formed by the aggregate mark for the multiple-choice questions papers and the Final Practical Test

Your results and Certificates will be sent to your Centre by ITEC. Therefore you will need to collect

your results and Certificates from your Centre

4. Assessment of the Qualification

The ITEC Level 2 Certificate in Barbering will be internally and externally assessed using a variety of assessment methods as set out in Table 1 and 2 above

Once you have completed all the specified assessments for the qualification and your Assessor has awarded a Pass mark for all the evidence you have submitted, you will have a Final Internal Practical Test

Internal Practical Assessment

Once all aspects of the mandatory units have been completed, you will complete a Final Internal Practical Assessment. This will be observed by your Assessor using the ITEC Internal Assessment forms. These will be reviewed by the ITEC External Verifier on the day of External Verification visit

a. Learners will be expected to perform the following Services:

- Client Consultation
- Shampoo and Condition
- Cut Men's Hair
- Cut Facial Hair
- Style Men's Hair

b. Final Practical Test sequence – Approximately 90 minutes

Client Consultation:

Unit 601 - Client Consultation for Hair Services

- Identify the client's needs and analyse the hair for porosity and previous treatments. Check skin and scalp for contraindications. Identify factors that could limit or affect the service. Advise clients and agree services and products

Shampoo and Condition:

Unit 602 – Shampoo and Condition the Hair and Scalp

- Shampoo and condition the hair and scalp using appropriate products and massage techniques

Cut Men's Hair:

Unit 604 - Cut Men's Hair

- Appropriate cutting technique(s) suitable for the client's hair type and according to the agreed desired look. All hair must be cut. A minimum of 1 cm must be removed from the hair

Cut Facial Hair:

Unit 610 - Cut Facial Hair

- Appropriate cutting technique(s) suitable for the client's hair type and according to the agreed desired look. All hair must be cut. A minimum of 0.5 cm must be removed from the hair

Styling/Dressing and Finishing:

Unit 312 - Styling Men's Hair

- Correct choice and use of styling equipment and products appropriate to hair type and desired finished look. All hair must be styled and finished to create a modern style

c. You will be asked oral questions during the Final Practical Test

d. You will need to complete Consultation Forms for your client for each unit and make available for the ITEC External Verifier to check. These should be reviewed and completed at the end of the service

e. You will need to demonstrate excellent hygiene and client care throughout your assessment as well as competence in all your skills

Multiple-choice Tests

Each question is formatted in the same way:

- 1 stem (the question)
- 1 key (the correct answer)
- 3 distractors (incorrect answers)
- You must indicate the answer you believe is correct by placing a mark in the appropriate box on your answer sheet

Multiple-choice tests are used for units 312, 600, 601, 602, 604, 610, 605, 606, 607, 608, 609, 611, 629 and 630. Online testing of all relevant units is also available

Portfolio of Evidence

Portfolio of evidence forms part of the internal assessment of your qualification and should be assessed throughout your training by your Assessor using the appropriate ITEC guidance forms. You are required to provide evidence of services that you have performed on clients during your training, under the supervision of your Assessor who will monitor the quality of your client services in order to ensure that they meet the ITEC criteria

- The criteria are detailed on the Record of Assessment Pages. They are graded Pass or Refer
- You will need to complete a Client Consultation Form as evidence that you performed the required number of services during your training (see Table 1 and 2) as they form part of your internal assessment for the qualification. They can be stored in your ITEC E-portfolio

5. Resources

Your Centre must provide a suitable environment for teaching the ITEC Level 2 Certificate in Barbering as well as all equipment both fixed and free standing to complete all aspects of the qualification. You may need to supply some consumables, hairdressing tools and/or towels in order to complete your training

6. Opportunities for Progression

Once you have achieved the ITEC Level 2 Certificate in Barbering you may progress on to other ITEC or equivalent qualifications at Level 2 or 3, for example:

- Level 2 Apprenticeship in Barbering
- Level 3 Certificate in Barbering
- Level 3 Apprenticeship in Barbering
- Level 3 Diploma in Hairdressing
