<p>1.12 Describe the contraindications which prevent or restrict pedicure treatments</p>	<p>1.12.1 To include:</p> <p>Contraindications requiring medical permission – in circumstances where medical permission cannot be obtained clients must sign an informed consent form stating that the treatment and its effects have been fully explained to them and confirm that they are willing to proceed without permission from their GP</p> <ul style="list-style-type: none"> • Haemophilia • Any condition already being treated by a GP, dermatologist or another practitioner • Medical oedema • Arthritis • Nervous or Psychotic
