1.8	Describe the type of test that is carried out before providing an eyelash perming treatment	<p>1.8.1 To include:</p> <ul style="list-style-type: none"> <li>• Skin sensitivity test • Patch testing for ALL solutions to be conducted a minimum of 24-48 hours prior to treatment • Manufacturers' instructions</li> <li>• Assessment of eye size and shape • Inspection of lashes to be treated</li> </ul>

1.13	Describe the contraindications which prevent or restrict eyelash perming	1.13.1 To include: <b>Contraindications requiring medical permission – in circumstances where medical permission cannot be obtained clients must sign an informed consent form stating that the treatment and its effects have been fully explained to them and confirm that they are willing to proceed without permission from their GP:</b> • Medical oedema • Nervous/Psychotic conditions • Epilepsy • Recent facial surgery affecting the area • Diabetes • Skin cancer • Slipped disc • Undiagnosed pain • When taking prescribed medication • Whiplash <b>Contraindications that restrict treatment:</b> • Fever • Contagious or infectious diseases • Under the influence of recreational drugs or alcohol • Diarrhoea and vomiting • Any known allergies • Eczema • Undiagnosed lumps and bumps • Localised swelling • Inflammation • Cuts • Bruises • Abrasions • Scar tissue (2 years for major operations and 6 months for a small scar) • Sunburn • Hormonal implants • Urticaria • Recent fractures (minimum 3 months) • Sinusitis • Neuralgia

2.13	State the contra-actions that may occur during and following treatments and how to respond	<p>2.13.1 To include:</p> <ul style="list-style-type: none"> <li>• Allergic reaction • Excessive erythema • Itching • Watery eyes • Inflammation • Infection • Client abuse i.e. rubbing/picking • Loss of natural lashes • Lower and upper lash adhesion • Foreign body enters clients eye i.e. lash/adhesive/dust • Uneven lift/curl • Lower lashes are kinked or curl upward</li> <li>• Results are different to each eye • Immediate removal of products • Saline eye irrigation procedure • Referral procedures</li> </ul>
