



**ITEC Level 2**  
**Unit 808 Provide Eyelash Perming**  
**Marking Criteria**

**APPEARANCE – 5 MARKS (0.5 mark each)**

**The candidate demonstrated:**

1. Clean, ironed professional uniform
2. Clean, neat hair, tied back/up if long and off the collar and face
3. Short, clean, well manicured nails with no varnish and clean hands
4. Clean, sensible full flat shoes, socks should be worn
5. Tights were an appropriate colour for the uniform, if wearing a skirt
6. No jewellery- with the exception of a wedding band and 1 pair of small stud earrings (religious jewellery must be taped)
7. No body or breath odour
8. No chewing gum or sucking sweets
9. No visible underskirts/underwear
10. Skirts to the knee. Trousers cropped no higher than calf/ trousers not trailing on the floor

**CLIENT CARE – 5 MARKS (1 mark each)**

**The candidate:**

1. Greeted and introduced self to client
2. Assisted the client off the couch
3. Explained the treatment procedure to the client
4. Ensured the client's comfort/ modesty throughout
5. Maintained a positive and professional approach to client/colleagues throughout

**HYGIENE AND STERILISATION – 10 MARKS (2 marks each)**

**The candidate:**

1. Wiped equipment over with appropriate sanitiser before and after use
2. Sanitised hands before, during and after treatment as appropriate
3. Replaced lids on products and used spatulas to remove cream
4. Disposed of cotton wool, tissues, paper roll and general waste hygienically and appropriately
5. Used salon/clinic sterilising equipment/cabinets appropriately and sanitised, used and stored small equipment appropriately

**EYELASH PERMING– 20 MARKS (1-7 – 1 mark each, 7 - 3 marks, 8-17 – 1 mark each)**

**The candidate:**

1. Cleansed the eye and eyebrow area using suitable cleansing techniques
2. Demonstrated awareness of contraindications
3. Ensured that the client has had a patch test
4. Selected a perming rod/roller size suitable for client's lashes and treatment requirements
5. Applied the glue to the eyelid following manufactures' instructions
6. Prepared and positioned the perming rod/roller correctly
7. Applied the lashes to the perming rod/roller
8. Applied the perm solution according to manufacturers' instructions
9. Removed any excess perm lotion and allowed suitable processing time
10. Removed perm lotion in the correct manner
11. Applied setting lotion according to manufacturers' instructions
12. Removed excess setting lotion and allowed suitable processing time
13. Removed setting lotion correctly
14. Removed perming rod/roller correctly
15. Applied nourishing lotion according to manufacturers' instructions
16. Achieved an even finished result
17. Concluded the treatment in a commercially acceptable time

**HOME CARE ADVICE – 10 MARKS (2 marks each)**

**The candidate:**

1. Documented the client's response to the treatment
2. Made recommendations for follow-on appointment
3. Made recommendations for immediate aftercare
4. Made recommendations for home care advice
5. Informed the client of the short term effects of the treatment

2. How would you perform a patch test?
3. How long before a treatment should a patch test be performed?
4. How long would a full treatment take
5. What aftercare advice would you give to the client?
