

**MARKING CRITERIA**  
**ITEC LEVEL 2**  
**Unit 809 – Apply Individual Permanent Eyelashes**

**APPEARANCE – 5 MARKS (0.5 marks each)**

**The learner demonstrated:**

1. Clean, ironed, professional uniform
2. Clean, neat hair – tied back/up if long and off the collar and face
3. Clean, short nails, well manicured with no varnish and clean hands
4. Clean, sensible, full, flat shoes worn with socks or tights
5. Tights were an appropriate colour for the uniform, if wearing a skirt
6. No jewellery – with the exception of a wedding band and 1 pair of small stud earrings (religious jewellery must be taped)
7. No body or breath odour
8. No chewing gum or sucking sweets
9. No visible underskirts/underwear
10. Trousers cropped no higher than calf/trousers not trailing on the floor and skirts to the knee

**CLIENT CARE – 5 MARKS (1 mark each)**

**The learner:**

1. Greeted and introduced self to client
2. Positioned self and client correctly throughout treatment
3. Explained the treatment procedures to the client
4. Ensured client's comfort/modesty, assisting them throughout treatment
5. Communicated and behaved in a professional manner throughout

**HYGIENE AND STERILISATION – 10 MARKS (2 marks each)**

**The learner:**

1. Followed health and safety working practices throughout
2. Used products, tools and equipment in a hygienic manner
3. Disposed of cotton wool, tissues, paper roll and general waste hygienically and appropriately
4. Ensured footwear for clients was stowed under the couch/chair and that the client did not walk around with bare feet
5. Managed the treatment and work environment throughout

**APPLICATION OF EYELASH EXTENSIONS - 70 MARKS (5 marks each)**

**The learner:**

1. Cleansed the eye area using suitable cleansing techniques
2. Demonstrate awareness of contraindications
3. Ensured that the client has had a patch test
4. Prepared and protected the eye area appropriately
5. Combed through eyelashes
6. Selected individual permanent lashes suitable for the client
7. Applied the glue to the extension in the correct quantities, following manufacturer's instructions and minimising waste
8. Separated the natural lashes and selected suitable natural lash to support extension
9. Positioned the extension in the correct manner
10. Supported the extension to achieve the correct position
11. Continued application correctly
12. Checked lash separation after completing application
13. Achieved an even finish result
14. Concluded the treatment in a commercially acceptable time

**HOME CARE ADVICE - 10 MARKS (2 marks each)**

The learner:

1. Documented client response to treatment
2. Made recommendations for follow-on appointments
3. Made recommendations for immediate aftercare
4. Made recommendations for home care advice
5. Informed the client of the short term effects of the treatment

1. Describe the contraindications to this treatment
2. How would you perform a patch test?
3. How long before a treatment should a patch test be performed?
4. How long does the glue take to set?
5. What after care advice would you give to the client?
