

Marking Criteria
ITEC Level 2
Unit 815 – Provide Threading

APPEARANCE – 5 MARKS (0.5 marks each)

The candidate demonstrated:

1. Clean, ironed professional uniform
2. Clean, neat hair - tied back/up if long and off the collar and face
3. Short, clean well manicured nails with no varnish and clean hands
4. Clean, sensible full flat shoes, socks should be worn
5. Tights were an appropriate colour for the uniform, if wearing a skirt
6. No jewellery - with the exception of a wedding band and 1 pair of small stud earrings (religious jewellery must be taped)
7. No body or breath odour
8. No chewing gum or sucking sweets
9. No visible underskirts/underwear
10. Skirts to knee. Trousers cropped no higher than calf/trousers not trailing on the floor

CLIENT CARE – 5 MARKS (1 mark each)

The candidate:

1. Greeted and introduced self to client
2. Assisted client off the couch.
3. Explained the treatment procedure to the client.
4. Ensured the client's comfort/modesty throughout.
5. Maintained a positive and professional approach to client/colleagues throughout.

HYGIENE AND STERILISATION – 10 MARKS (2 marks each)

The candidate:

1. Wiped equipment over with appropriate sanitiser before and after use.
2. Sanitised hands before, during and after treatment as appropriate.
3. Replaced lids on products and used spatulas to remove cream.
4. Disposed of cotton wool, tissues, paper roll and general waste hygienically and appropriately.
5. Used salon/clinic sterilising equipment/cabinets appropriately and sanitised, used and stored small equipment appropriately.

THREADING TREATMENT – 20 marks (2 marks each)

The candidate:

1. Carried out a consultation and checked for contraindications
2. Discussed clients requirements and possible contra-actions
3. Assessed the area to be treated
4. Ensured the client supported the skin appropriately
5. Removed hairs quickly and efficiently
6. Ensured all hairs are removed from the area
7. Applied soothing aftercare product
8. Completed treatment to clients satisfaction
9. Disposed of the used thread hygienically
10. Completed treatment in a commercially acceptable time

AFTER/HOME CARE ADVICE - 10 MARKS (2 marks each)

The candidate:

1. Documented the client's responses to the treatment
2. Made recommendations for follow-on appointment
3. Made recommendations for immediate aftercare
4. Made recommendations for home care advice
5. Informed the client of the short term effects of the treatment

1. Describe the client's skin type?
2. What type of hair grows on the facial area?
3. What is the specific aftercare advice for this treatment?
4. Describe the contraindications to this treatment?
5. How often would you recommend the client to have a threading treatment?
