

# Purpose ITEC Level 4 Diploma in Laser and Light Treatments (QAN 600/0595/6)

#### **Aims and Objectives**

The main aim of the ITEC Level 4 Diploma in Laser and Light Treatments is to enable Learners to gain the necessary practical skills and knowledge in order to provide Laser and Light Treatments for hair removal and skin rejuvenation to the general public and to gain employment in the Beauty Industry. The qualification is suitable for Learners aged 18 and over and is designed to provide occupational competence at Level 4. It also provides a sound platform into further learning at Levels 4 and 5

#### **Recommended Prior Learning**

Learners must hold the ITEC Level 2 Diploma for Beauty Specialists or equivalent before commencing the ITEC Level 4 Diploma in Laser and Light Treatments

#### Content

This qualification is for Learners who want to work in an advanced skincare clinic, beauty salon or spa and is comprised of 4 core units which are mandatory

The main skills you will perform are:

- Laser and Light Treatments for hair removal to include consultation, skin and hair analysis, recognising contraindications and contra-actions, carrying out relevant tests prior to treatment and adapting the treatment to the client's needs
- Laser and Light Treatments for skin rejuvenation to include consultation, skin analysis (Fitzpatrick scale), recognising contraindications and contra-actions, carrying out relevant tests prior to treatment and adapting the treatment to the client's needs
- Managing health, safety and security in the salon

You will also learn about client care and communication and the physiology of ageing which is essential in order to work and be successful in the industry

#### It also provides:

- the related knowledge and understanding required to perform the Laser and Light Treatments listed above effectively in particular anatomy and physiology and common diseases and disorders that may affect when a client should or should not receive treatment
- opportunities for Learners to focus on the development of their wider skills in a Laser and Light setting, such as communicating with clients, working with others and problem solving
- opportunities for Learners to develop a range of skills, techniques, personal qualities and attitudes essential for successful performance in employment as a Laser and Light Technician

The ITEC Level 4 Diploma in Laser and Light Treatments is a vocational qualification recognised by Ofqual within the Qualifications and Credit Framework (QCF)

There are opportunities for a Laser and Light Technician to find employment in a variety of areas:

- Advanced skincare clinic
- Beauty salon
- Spa
- Own business
