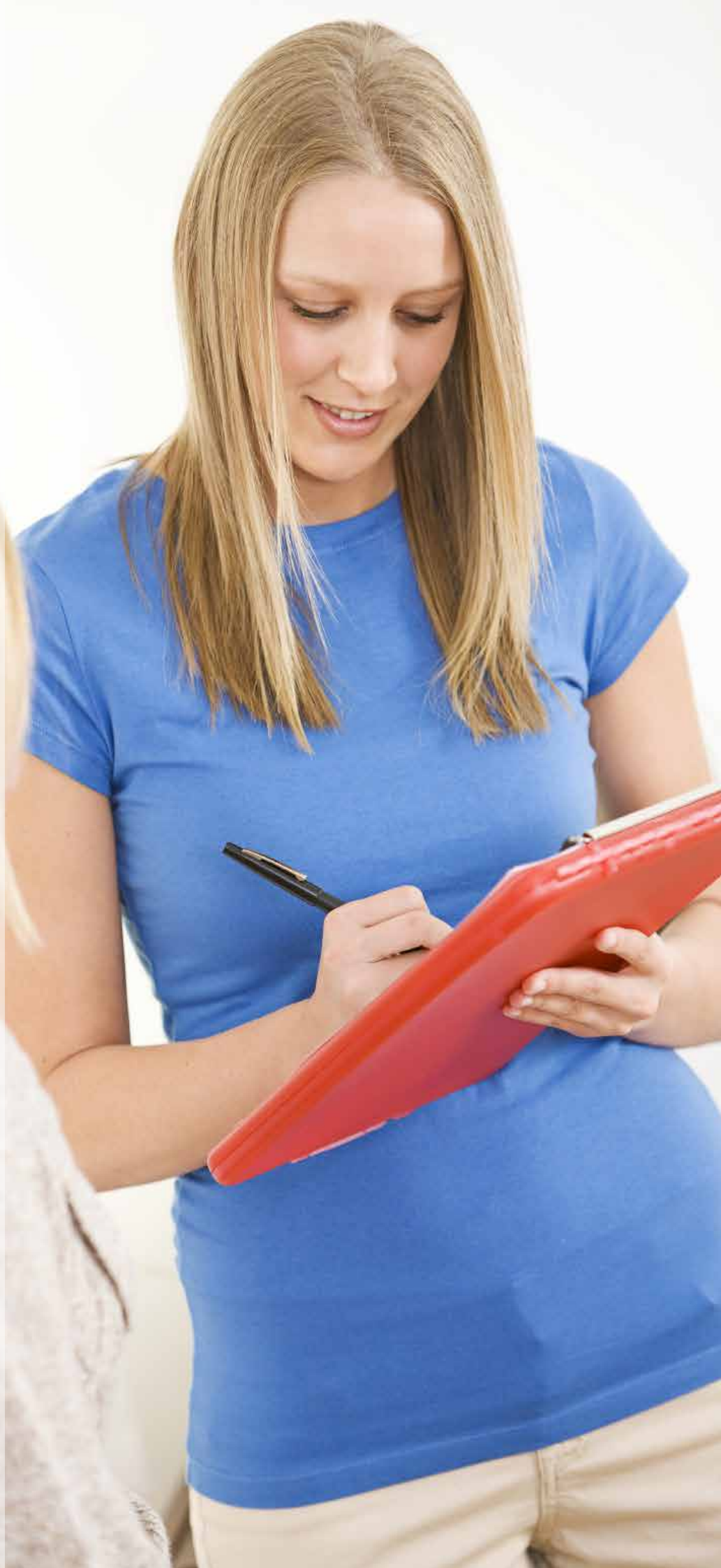

1. Environment
