Explain and recognise those general contra-indications to waxing requiring medical permission or the client to sign an informed consent form prior to the treatment and those contra-indications that restrict treatment	<ul style="list-style-type: none"> • Contra-indications requiring medical permission – in circumstances where medical permission cannot be obtained, clients must sign an informed consent form stating that the treatment and its effects have been fully explained to them and confirm that they are willing to proceed without permission from their GP <ul style="list-style-type: none"> - Cardiovascular conditions <ul style="list-style-type: none"> • Thrombosis • Phlebitis • Hypertension • Hypotension • Heart conditions - Haemophilia

	2.3. Explain the cause of ingrowing hairs and treatment	<ul style="list-style-type: none"> • Dry skin • Shaving • Hairs break off when waxing • Lack of exfoliation and moisturiser • Incorrect hair removal • Distorted follicles

LO3 Be able to carry out waxing treatments	3.1. Explain and demonstrate use of products, tools and equipment	<ul style="list-style-type: none"> • Hot wax • Warm/cool wax • Pre/after-wax lotions • Disposable spatulas • Cotton wool • Waxing strips • Tweezers
	3.2. Explain and demonstrate how to treat different areas	<ul style="list-style-type: none"> • Under arms • Back • Chest • Abdomen • Bikini line • Brazilian • Hollywood • Leg • Lip • Chin • Forearms • Eyebrows
	3.3. Explain and demonstrate how to sanitise the area to be treated	<ul style="list-style-type: none"> • Wipe over the area to be waxed with sanitiser or with a pre-wax treatment

	3.4. Explain the composition and ingredients of depilatory products and explain their appropriate use	<ul style="list-style-type: none"> • Hot wax • Warm/cool wax
	3.5. Describe and demonstrate how to perform a thermal test on self and client	<ul style="list-style-type: none"> • The heated wax should be tested on the therapist's wrist first to check the temperature • The heated wax should then be tested on the wrist or the ankle of the client to ensure it is not too hot
	3.6. Explain and demonstrate application of warm/cool wax evenly, sparingly and ensuring cost effectiveness throughout	<ul style="list-style-type: none"> • Spatula held at right angles to the area to be waxed ensuring that wax drips from the top to the bottom of the spatula ensuring a thin even distribution of wax
	3.7. Explain and demonstrate application of hot wax evenly ensuring cost effectiveness throughout	<ul style="list-style-type: none"> • Check length of hair (minimum 1cm) • Trim overly long hairs • Check direction in which hairs grow • Apply wax first against the hair growth or in line with manufacturer's instructions
	3.8. Explain and demonstrate removal of the product	<ul style="list-style-type: none"> • Using the appropriate method for the product selected • Ensuring removal is performed in the correct direction, angle and speed • Minimising discomfort to the client
	3.9. Explain and demonstrate how to clear the area effectively	<ul style="list-style-type: none"> • Do not re-wax over an area which has already been treated with hot wax • Tweeze out any stray hairs
	3.10. The learner will be able to explain and demonstrate safe disposal of waste	<ul style="list-style-type: none"> • Where blood spots may have occurred, care must be taken with the contaminated waste to include: <ul style="list-style-type: none"> - Place in a plastic bag - Put in a separate bin (containing chemical) to be taken away and incinerated

Explain and demonstrate the ability to work quickly and efficiently to a standard acceptable by the industry	<ul style="list-style-type: none"> • The treatment should be performed in a commercially acceptable time: <ul style="list-style-type: none"> - Full leg – 40 minutes - Half leg – 20 minutes - Underarm and bikini – 15 minutes each - Back – 30 minutes - Chest – 20 minutes - Abdomen – 15 minutes - Brazilian – 30-40 minutes

		<ul style="list-style-type: none"> - Hollywood – 45-50 minutes - Lip – 10 minutes - Chin – 10 minutes - Forearms – 20 minutes - Eyebrows – 15 minutes

Explain and demonstrate accurate updating of client records	<ul style="list-style-type: none"> • Contra-indications must be checked and noted appropriately • A note should be made of the area(s) to be waxed • Any notes regarding skin's reaction should be made at the end of the treatment • Aftercare advice • Home care advice • Record and store in line with current data protection legislation and professional code of conduct
	3.13. Explain the advantages and disadvantages of the use of each wax product and method	<ul style="list-style-type: none"> • Composition • Working temperature according to manufacturer's instructions • Method of application • Method of removal
	3.14. Explain other forms of depilation	<ul style="list-style-type: none"> • Tweezing • Shaving • Depilatory creams • Sugaring • Threading • Depilation machine • Abrasive mitts • Electrical epilation
