Synoptic practical examination criteria

Learners must complete a synoptic practical examination as part of the Level 3 Diploma in Hairdressing qualification. The practical examination will be externally set by VTCT (iTEC) and examined and marked by an External Examiner. Learners will be expected to demonstrate excellent hygiene and client care throughout the service as well as competence in their relevant skills.

Client requirements

Centres must identify suitable clients for the examination. Centres may ask learners to identify suitable clients. Clients must meet all of the following requirements:

- be prepared for the service by having a skin test completed 24 - 48 hours prior to appointment, following manufacturer's instructions
- be 16 years or over
- be willing to have a minimum of 3cm of hair removed
- be willing to accept a physical and visible change in hair colour
- not have hairdressing knowledge or experience
- provide consent to participate

It is the responsibility of the centre and learner to work collaboratively to ensure a suitable client is provided for the examination purposes.

Learners will be expected to perform the following services for the synoptic practical examination:

Creatively colour and lighten hair

- Create a two-tone effect on the hair with the use of **two** different colouring and/or lightening products
- Use both a weaving and slicing technique
- Cover a minimum of 75% of the hair

Creatively cut hair using a combination of techniques

- A creative haircut, removing a minimum of 3cm from the hair

Creatively style and dress hair

- Style and dress the hair in accordance with creative haircut, incorporating the use of heated styling equipment

Time allocation

- The time allocated for this examination is a maximum of three hours and thirty minutes

Practical examination grade

All sections of the Examiner's Assessment Form must be demonstrated by the learner. Failure to demonstrate any section of the Examiner's Assessment Form will result in non-achievement of the practical examination. The practical examination will be graded:

- Pass 60% - 74%
- Merit 75% - 89%
- Distinction 90% - 100%

Marking criteria for Level 3 in Advanced Hairdressing

*In order to achieve a minimum of a pass grade, learners must achieve a minimum of 3 marks from each of the first 3 sections.

*Appearance – 5 marks (1 mark each)

The learner demonstrated:

1. Clean, ironed professional wear with no visible underwear and fully enclosed shoes worn
2. Clean, neat, styled hair
3. Clean, maintained hands and nails
4. Appropriate personal protective clothing throughout the service
5. Professionalism by not chewing gum, no sucking of sweets and no body or breath odour

*Client care – 5 marks (1 mark each)

The learner:

1. Greeted and introduced self to client and assisted the client to the chair/work station
2. Explained the service procedure thoroughly to the client
3. Ensured correct positioning of the client, protected the client's clothing and skin appropriately and checked the client's comfort throughout the service
4. Maintained a positive and professional approach to client throughout the service
5. Employed ergonomic working practices throughout the service

*Hygiene and sterilisation – 5 marks (1 mark each)

The learner:

1. Wiped equipment and work area over with appropriate sanitiser before and after use
2. Sanitised hands before, during and after service as appropriate
3. Used clean towels and gowns throughout the service
4. Ensured that lids are replaced on products and disposed of general waste hygienically and appropriately
5. Maintained own work area and equipment, used and stored equipment appropriately

Provide client consultation services – 10 marks (2 marks each)

The learner:

1. Used a variety of consultation techniques to identify the client's needs and expectations of the service
2. Conducted appropriate consultation tests to analyse the hair and scalp and identified any previous chemical treatments
3. Checked the skin and scalp for any contra-indications to the service
4. Identified any influencing factors that could limit or affect the service
5. Advised clients, agreed services and products and provided aftercare advice and recommendations to the client

Creatively colour and lighten hair – 25 marks (5 marks each)

The learner:

1. Prepared the work area and assembled all tools and equipment required in preparation for the creative colour and/or lighten service
2. Selected suitable colouring products for the client's requirements and mixed the colouring and/or lightening products in accordance to manufacturer's instructions
3. Performed the colour application accurately and in accordance to the agreed desired look
4. Conducted strand tests at suitable times throughout the developing process to check accuracy of the application, and performed visual checks to ensure exact development time of colouring and/or lightening products
5. Ensured the removal of colouring and/or lightening products was thorough to confirm the hair and scalp were free of colour and the desired colouring effect had been achieved

Creatively cut hair using a combination of techniques – 25 marks (5 marks each)

The learner:

1. Selected the correct tools and equipment to create the agreed desired look
2. Applied the appropriate cutting techniques safely, which were suitable for the client's hair classification type, the hair's condition and the agreed desired look
3. Applied an even degree of tension to the hair and maintained even moisture in the hair throughout the creative cutting service
4. Performed the creative haircut using the appropriate cutting angles and sectioning patterns for the agreed desired look, and worked in a methodical manner
5. Performed cross-checking methods of the creative haircut

Creatively style and dress hair – 25 marks (5 marks each)

The learner:

1. Selected and used the appropriate styling and finishing products in accordance with the hair classification type, hair's condition and agreed desired finished look
2. Applied accurate and appropriate sectioning methods throughout the creative styling and dressing service
3. Ensured the correct use of styling equipment and applied effective control of the client's hair during the styling and dressing process
4. Ensured the correct use of heated equipment and applied effective control of the client's hair during the styling and dressing process
5. Confirmed the finished look is balanced and meets the agreed desired effect
