

# Marking Criteria

## iUBT331 – Provide eyelash and eyebrow treatments

Once all aspects of the mandatory units have been completed, learners will be expected to complete an internal practical assessment. This will be undertaken by an internal assessor using the internal assessment forms. These must be handed to the external examiner on the day of the final external practical examination.

Practical skills - examination sequence – approximately 30 minutes

- Consultation forms may be partially filled out prior to the practical examination
- Client should be on the couch
- Cleanse and prepare the eye area
- Eyelash and eyebrow tint
- Eyebrow shape
- Check finished results with client
- Complete consultation form and hand to the examiner at the end of the treatment
- Oral questions may be asked at any time during the examination
- Consultation forms must be filled in by each learner for the unit and made available for the external examiner to check. These should be reviewed and completed at the end of the treatment and will be taken away by the examiner
- Learners will be expected to demonstrate excellent hygiene and client care throughout as well as competence in their relevant skills
- The examiner may reduce the treatment timings, as the examination is a demonstration of the Learner's professionalism and their accomplished technique
- Approximate time allocated for changeover of practical examination groups – 15 minutes

Learners must achieve a minimum of 3 marks for appearance and 3 marks for client care in order to pass the practical examination.

Learners must be able to demonstrate the following:

### **Appearance – 5 marks (0.5 mark each)**

1. Clean, ironed professional uniform
2. Clean, neat hair and tied back. Hair must be tied up if long and off the collar, not covering face
3. Short, clean, well-manicured nails with no varnish and clean hands
4. Clean, sensible fully flat shoes, socks should be worn
5. If wearing a skirt, tights must be an appropriate colour for the uniform
6. No jewellery to be worn with the exception of a wedding band and 1 pair of small stud earrings. Other religious jewellery must be taped accordingly
7. No body or breath odour
8. No chewing gum or sucking sweets
9. No visible underskirts/underwear
10. Skirts to the knee. Trousers should be cropped no higher than calf length and trousers must not be trailing on the floor

**Client care – 5 marks (1 mark each)**

1. Greeted and introduced self to client
2. Positioned self and client appropriately throughout the treatment
3. Explained the treatment procedure to the client
4. Ensured the client's comfort and modesty throughout the treatment
5. Maintained a positive and professional approach to client throughout

**Hygiene and sterilisation – 10 marks (2 marks each)**

1. Wiped the equipment over with an appropriate sanitiser before and after use
2. Sanitised hands before, during and after treatment as appropriate
3. Replaced lids on products and used spatulas to remove cream
4. Appropriate and hygienic disposal of cotton wool, tissues, paper roll and general waste
5. Ensured the salon, clinic sterilising equipment and cabinets are used appropriately and sanitised correctly. Small equipment must also be used and stored appropriately

**Preparation for tinting – 5 marks (2.5 marks each)**

1. Checked for any contra-indications and evidence of the client's patch test
2. Used suitable cleansing techniques to cleanse the eyelashes and eyebrow area

**Eyelash tinting – 20 marks 1-5 (2 marks each) and 6 (10 marks)**

1. Protected the surrounding skin and prepared treatment area appropriately
2. Mixed the appropriate tint colour to meet the client's needs
3. Mixed the tint to the appropriate consistency according to manufacturer's instructions and to minimise waste
4. Applied the tint thoroughly and carefully from the hair root to the tip
5. Removed the tint efficiently and carefully avoiding any discomfort to the client
6. Performed the treatment to a commercially acceptable standard and created an evenly coloured eyelashes in a commercially acceptable time

**Eyebrow tinting – 20 marks 1-5 (2 marks each) and 6 (10 marks)**

1. Protected surrounding skin and prepared treatment area appropriately
2. Mixed the appropriate colour to meet the client's needs
3. Mixed the tint to the appropriate consistency according to manufacturer's instructions and to minimise waste
4. Applied the tint thoroughly and carefully
5. Removed the tint efficiently and carefully avoiding any discomfort to the client
6. Performed the treatment to a commercially acceptable standard and created evenly coloured eyebrows in a commercially acceptable time

**Brow shape – 25 marks (5 marks each)**

1. Discussed the client's requirements and agreed the shape according to the client's needs
2. Measured the eyebrows correctly
3. Gloves are worn and the skin is stretched when performing the treatment
4. Positioned self and client appropriately, removed hairs quickly and efficiently placing the removed hairs on a tissue or cotton wool
5. Checked for client's comfort throughout and approval of the finished result

**Home care advice – 10 marks (2 marks each)**

1. Appropriately concluded the treatment
2. Made recommendations for follow-on appointment
3. Made recommendations for immediate aftercare
4. Made recommendations for home care advice
5. Informed the client of activities to avoid that may cause contra-actions

**Sample oral questions**

1. Describe the contra-indications to this treatment
2. How would you perform a patch test?
3. How long before a treatment should a patch test be performed?
4. How long does the tint take to oxidise?
5. What aftercare advice would you give to the client?
