
Marking Criteria

iUBT346 – Provide eyelash perming

Once all aspects of the mandatory units have been completed, learners will be expected to complete an internal practical assessment. This will be undertaken by an internal assessor using the internal assessment forms. These must be handed to the external examiner on the day of the final external practical examination.

Practical examination sequence – approximately 45 minutes

- Consultation forms may be partially filled out prior to the practical examination
- The client should be on the couch ready for the exam
- Cleanse and prepare the eye area
- Eyelash perming
- Check finished results with the client
- Oral questions may be asked at any time during the examination
- Consultation forms must be filled in by each learner, and made available for the external examiner to check. These should be reviewed and completed at the end of the treatment and will be taken away by the external examiner
- Learners will be expected to demonstrate excellent hygiene and client care throughout as well as competence in their relevant skills
- The examiner may reduce the treatment timings, as the examination is a demonstration of the learner's professionalism and their accomplished technique
- Approximate time allocated for changeover of practical examination groups – 15 minutes

Learners must achieve a minimum of 3 marks for appearance and 3 marks for client care in order to pass the practical examination.

Learners must be able to demonstrate the following:

Appearance – 5 marks (0.5 marks each)

1. Clean, ironed professional uniform
2. Clean, neat hair and tied back. Hair must be tied up if long and off the collar, not covering the face
3. Short, clean, well-manicured nails with no varnish and clean hands
4. Clean, sensible fully flat shoes, socks should be worn
5. Tights an appropriate colour for the uniform, if wearing a skirt
6. No jewellery to be worn, with the exception of a wedding band and 1 pair of small stud earrings (religious jewellery must be taped)
7. No body or breath odour
8. No chewing gum or sucking sweets
9. No visible undershirts/underwear
10. Skirts to the knee. Trousers should be cropped no higher than calf/ trousers not trailing on the floor

Client care – 5 marks (1 mark each)

1. Greeted and introduced self to client
2. Positioned self and client correctly throughout treatment
3. Explained the treatment procedures to the client
4. Ensured client's comfort/modesty, assisted them throughout treatment
5. Communicated and behaved in a professional manner throughout

Hygiene and sterilisation – 10 marks (2 marks each)

1. Followed health and safety working practices throughout
2. Used products, tools and equipment in a hygienic manner
3. Disposed of cotton wool, tissues, paper roll and general waste hygienically and appropriately
4. Ensured footwear for clients was stowed under the couch/chair and that the client did not walk around with bare feet
5. Managed the treatment and work environment throughout

Preparation of treatment area and client – 5 marks (1 mark each)

1. Carried out a consultation and checked for contra-indications
2. Assessed the area to be treated and had evidence of a patch test
3. Discussed client's requirements and possible contra-actions to treatment
4. Selected products, tools and equipment to suit client's treatment needs
5. Prepared work environment, self and client for treatment

Eyelash perming – 65 marks (1-15 4 marks each, 16 – 5 marks)

1. Cleansed the eye area using suitable cleansing techniques and prepared and protected the eye area appropriately
2. Selected a perming rod/roller/silicone shield of suitable size for client's lashes and treatment requirements
3. Applied adhesive to the eyelid in the correct quantities, following manufacturer's instructions
4. Prepared and positioned the perming rod/roller/silicone shield appropriately ensuring it is not bent or crossed
5. Applied the lashes to the perming rod/roller in the correct manner and following manufacturer's instructions
6. Applied the perm/lifting solution using the appropriate tools and techniques and according to manufacturer's instructions
7. Removed any excess perm/lifting lotion using appropriate tools and techniques and according to manufacturer's instructions
8. Allowed suitable processing time, and maintained contact with client
9. Removed perm/lifting lotion appropriately and according to manufacturer's instructions
10. Applied setting/neutralising lotion using appropriate tools and techniques and according to manufacturer's instructions
11. Removed excess setting/neutralising lotion using appropriate tools and techniques and according to manufacturer's instructions
12. Allowed suitable setting/neutralising time and maintaining contact/communication with the client
13. Removed setting/neutralising lotion using appropriate tools and techniques and according to manufacturer's instructions

14. Removed perming rod/roller/eye shield appropriately and according to manufacturer's instructions
15. Applied nourishing lotion using appropriate tools and techniques and according to manufacturer's instructions
16. Concluded treatment in the appropriate manner in a commercially acceptable time, achieving a commercially acceptable finished result

Aftercare advice – 10 marks (2 mark each)

1. Documented client response to treatment and client feedback
2. Informed the client of the short-term effects of treatment and recommended and provided immediate aftercare
3. Advised the client of possible contra-actions and how to deal with them
4. Recommended and recorded home care and product advice
5. Recommended and recorded follow on appointment(s)

Sample oral questions

1. Describe the contra-indications to this treatment
2. How would you perform a patch test?
3. How long before a treatment should a patch test be performed?
4. How long would a full treatment take?
5. What aftercare advice would you give to the client?
