



## **ITEC Level 2 NVQ Diploma in Beauty Therapy General**

### **Specification**

#### **Aims and Objectives**

The main aim of the ITEC Level 2 NVQ Diploma in Beauty Therapy General is to enable Learners to gain the necessary practical skills and knowledge in order to provide Beauty Therapy services to the general public and to gain employment in the Beauty Industry. The qualification is suitable for Learners aged 16 and over and is designed to provide occupational competence at Level 2. It also provides a sound platform into further learning at Levels 2 and 3

#### **Content**

This qualification is for Learners who want to work within the Beauty Industry. The qualification consists of 8 units, all of which are mandatory; Learners must also select optional units covering a minimum of 70 hours of guided learning (GL). A minimum of 458 hours of guided learning are required to achieve the full qualification

The main skills the learner will perform are:

- Consultation techniques – to include planning and preparation, contraindications and contra-actions
- Facial skincare treatments – to include cleansing, exfoliation, massage, facial masks and adapting the treatment to suit the client's specific needs
- Manicure and Pedicure – to include care of the nails on the hands and feet, hand and foot massage and application of polish
- Enhancing the appearance of eyebrows and eyelashes – to include grooming and shaping the eyebrows and tinting lashes and brows
- Waxing – to include removal of hair using hot and cool waxing techniques

The Learner will also develop knowledge about related health and safety and client care and communication which is essential to work and be successful in the Beauty Industry

The learner will also be able to choose from a range of optional units to complete the qualification, for example:

- Provide Make-up Services
- Provide Threading Services
- Assist with Spa Operations
- Enhance Appearance Using Skin Camouflage
- Carry out Ear Piercing
- Fulfil Salon Reception Duties

The qualification also provides:

- The related knowledge and understanding required to perform the Beauty Therapy skills listed above; in particular, the anatomy and physiology of the body and common diseases and disorders that may affect when a client should or should not receive treatment

- Opportunities for Learners to focus on the development of their wider skills in a Beauty Therapy setting, such as; communicating with clients, working with others and problem solving
- Opportunities for Learners to develop a range of skills, techniques, personal qualities and attitudes essential for successful performance in employment as a Beauty Therapist

### Why Choose the ITEC Level 2 NVQ Diploma in Beauty Therapy General?

1. This Qualification combines the full range of skills and knowledge for the Learner seeking employment or self-employment as a Beauty Therapist at Level 2. This qualification is the only ITEC Level 2 NVQ Diploma in Beauty Therapy General that meets the current National Occupational Standards

3. This Qualification is listed in the Ofqual Register of Qualifications
4. This Qualification contains all the skills and knowledge required for employability at Level 2
5. Learners may progress on to the ITEC Level 3 NVQ Diploma in Therapy General, the ITEC Level 3 NVQ Diploma in Beauty Therapy Massage, the ITEC Level 3 Diploma in Beauty Therapy Make-up, the ITEC Level 3 Diploma in Nail Services or the ITEC level 3 Diploma in Spa Therapy
6. This qualification also forms part of the level 2 Beauty Therapy Apprenticeship. This qualification can be studied outside the apprenticeship by learners who are unable to gain an apprenticeship position or are not eligible for an apprenticeship due to prior qualifications, but wish to be occupationally competent and employed as a Beauty Therapist
7. This qualification leads to employability and is the employer's preference with support from Beauty Therapy salons across the UK. It remains the qualification of choice amongst Further Education Colleges as local employers require it for their employees
8. This qualification is recognised by all relevant professional bodies within the Beauty Therapy Industry for membership and insurance purposes at Level 2

### **Guided Learning (GL)**

Guided Learning is the 'activity of a Learner in being taught or instructed by – or otherwise participating in education or training under the immediate guidance or supervision of – a Lecturer, Supervisor, Tutor or other appropriate provider of education or training'. This includes 'the activity of being assessed if the assessment takes place under the immediate guidance or supervision of a Lecturer, Supervisor, Tutor or other appropriate provider of education or training'

### **Total Qualification Time (TQT)**

Total Qualification Time is the number of notional hours which represents an estimate of the total amount of time that could reasonably be expected to be required in order for a Learner to achieve and demonstrate the achievement of the level of attainment necessary for the award of the qualification

### **Total Credit Value**

The total Credit Value for the qualification is equal to one tenth of the Total Qualification Time rounded to the nearest whole number.

This qualification will be internally and externally assessed using a range of assessment methods as set out in the table below: -

### Grading of the Qualification

All assessment tasks required for each unit of the qualification (detailed in table 1 and table 2 of the specification) and learners must also select units covering a minimum of 70 hours (detailed in table 2 of the specification) must be completed and awarded a Pass mark before the complete qualification can be certificated.

The overall qualification is graded as a Pass.

### Controlled Assessment

All theory tests must be conducted in a controlled environment and follow the procedures defined by ITEC [here](#). The theory tests will be set and marked by ITEC

All practical assessments must be conducted in a controlled environment as defined by ITEC [here](#). The internal assessment will be conducted by the centres Lecturer/Internal Verifier(s) and will be sampled by the ITEC External Verifier; however, the Centre is responsible for ensuring the assessment can operate seamlessly by organising the process as defined by ITEC in the Lecturer Guidance Notes [here](#). ### Recommended Prior Learning

It is recommended that Learners should have achieved a level of education equivalent to five GCSEs at grade A\*-C or a Level 1 NVQ Diploma in Beauty Therapy prior to commencing the ITEC Level 2 NVQ Diploma in Beauty Therapy - General; however, exemptions may be made for adult returners with experience of the workplace

## Opportunities for Progression

Once Learners have achieved the ITEC Level 2 NVQ Diploma in Beauty Therapy General they may progress on to other ITEC or equivalent qualifications at Level 3, for example:

- Level 3 NVQ Diploma in Therapy General
- Level 3 NVQ Diploma in Beauty Therapy Massage
- Level 3 Diploma in Beauty Therapy Make-up
- Level 3 Diploma in Nail Services
- Level 3 Diploma in Spa Therapy
