About this qualification

Aims and objectives

The main aim of the VTCT Skills (ITEC) Level 1 Diploma in Beauty Therapy is to provide learners with the foundation to progress to further learning and to gain the necessary basic practical skills and knowledge in order to assist with beauty treatments in the salon. The qualification is suitable for pre 16 learners and/or learners aged 16 and over and is a sound platform into further learning at levels 2.

Content

This qualification is for learners who want to progress to further learning in order to work in a beauty salon or spa. The qualification consists of 14 mandatory units with a total of 369 hours of Guided Learning (GL) to achieve the full qualification.

The main skills the learner will learn to perform are:

- Basic skincare – to include selecting products for the client's needs, performing cleansing and application and removal of face masks
- Basic hand and nail care – to include shaping, buffing and application of light coloured polish
- Basic foot and nail care – to include shaping, buffing and application of light coloured polish
- Nail art – to include selecting and applying products and techniques such as coloured polishes, gems and stones, marbling, dotting and freehand
- Basic make-up – to include products and application techniques
- Photographic make-up – to include selecting products and application techniques to suit the client's needs
- Designing a 2D image for face painting - to include applying face painting techniques using products, tools and equipment and adapting the 2D image to a 3D surface
- Head massage – to include classical massage movements and adapting to the client's needs
- Salon receptions duties
- Creating and maintaining retail displays for the salon

The learner will also learn about related health and safety, contra-indications and contra-actions to the treatments, consultation techniques, client care and communication and working with others in the beauty sector which is essential in order to work and be successful in the industry.

It also provides:

- The related knowledge and understanding required to perform the beauty treatments outlined above in particular the anatomy and physiology of the areas to be treated
- Opportunities for learners to focus on the development of their wider skills in a beauty therapy setting, such as communicating with clients, working with others and problem solving
- Opportunities for learners to develop a range of skills, techniques, personal qualities and attitudes which are essential in order to assist in the beauty salon or spa

Opportunities for progression

Once learners have achieved the VTCT Skills (ITEC) Level 1 Diploma in Beauty Therapy they may progress on to other VTCT Skills (ITEC) or equivalent qualifications at level 2 for example:

- Level 2 Diploma in Beauty Specialist Treatments
- Level 2 Diploma in Beauty Treatments

- Level 2 Diploma in Hair, Photographic and Media Make-up
- Level 2 Certificate in Bridal Make-up
- Level 2 Certificate on Manicure and Pedicure
- Level 2 Certificate in Liquid and Powder Nail Enhancements
- Level 2 Certificate in Wrap Nail Enhancements
- Level 2 Certificate in Gel Nail Enhancements

Opportunities for employment

There are opportunities for a beauty therapist at level 1 to find employment assisting with beauty treatments in a variety of areas:

- Beauty salons
- Make-up studios
- Nail studios

Relationship to National Occupational Standards

This qualification has mapped to National Occupational Standards where they exist and has ensured that best practice in the workplace has been reflected in the qualification. This qualification is linked to the relative job roles as well as ensuring that the qualification reflects the required level of knowledge and ability for the beauty therapist at level 1.

Qualification structure

To be awarded the VTCT Skills (ITEC) Level 1 Diploma in Beauty Therapy, learners must achieve all mandatory units.

The minimum GLH required to achieve this qualification is 369

The minimum TQT required to achieve this qualification is 420

Guided Learning Hours (GLH)

Guided Learning Hours is 'the activity of a learner in being taught or instructed by – or otherwise participating in education or training under the immediate guidance or supervision of – a lecturer, supervisor, tutor or other appropriate provider of education or training'. This includes 'the activity of being assessed if the assessment takes place under the immediate guidance or supervision of a lecturer, supervisor, tutor or other appropriate provider of education or training'.

Total Qualification Time (TQT)

Total Qualification Time is the number of notional hours which represents an estimate of the total amount of time that could reasonably be expected to be required, in order for a learner to achieve and demonstrate the achievement of the level of attainment necessary for the award of the qualification.

Assessment

This qualification will be internally and externally assessed via methods set out in Table 2 below. The assignments, practical assessment, tasks and treatment evidence will be internally assessed by the centre's lecturer/internal verifier(s) and externally quality assured by VTCT Skills (ITEC).

Grading of the qualification

Learners must achieve a Pass grade in the requisite number of units as specified in the rules of combination, see Table 1 above.

The overall qualification is graded Pass/Fail.

Theory examination

All theory tests must be conducted in a controlled environment and follow the procedures defined by VTCT Skills (ITEC). The theory tests will be set and marked by VTCT Skills (ITEC). The centre is responsible for ensuring the examination can operate seamlessly by organising the process as defined in the 'Instructions for Conducting Examinations' which can be found on the ITEC website.

Practical examination

Once all aspects of the mandatory units have been completed, learners will be expected to complete an internal practical assessment. This will be undertaken by the internal assessor/lecturer using the internal assessment forms. These may be sampled by an external quality assurer.

All practical assessments must be conducted in a controlled environment defined by VTCT Skills (ITEC). The practical assessment will be conducted by a centre assessor and evidence of these assessments may be sampled by an external quality assurer. The centre is responsible for ensuring the assessments can operate seamlessly by organising the process as defined in the 'Instructions for

Conducting Examinations’ which can be found on the iTEC website. The marking criteria and marking scheme can be found under the documents tab within the qualification.

Portfolio of evidence

Learners are required to provide assignments under the supervision of the lecturer who will monitor the quality of the assignments in order to ensure that they meet the criteria.

- The criteria are detailed on the assignment guidance forms and form part of the internal assessment for the qualification

Quality assurance

Delivery of the qualification

A scheme of work must be approved by VTCT Skills (ITEC) for all units prior to the commencement of the course.

Lecturers should aim to deliver the theory and practical of each unit simultaneously, i.e., both theory and practical of each unit should be taught together to ensure the underpinning knowledge is being delivered at the same time as the practical skills. This will help to ensure that learners understand the structures they are working on as a result of combining delivery with the practical application of treatments.

Centre resources

The organisation delivering the qualification must provide a suitable environment for teaching the VTCT Skills (ITEC) Level 1 Diploma in Beauty Therapy as well as all equipment both fixed and free standing to complete all aspects of the qualification. Learners need to be made aware of the amount of consumables/towels they will be required to provide.

Achievement record

All units will require an Achievement Record to be completed by the lecturer for each learner. This achievement record will need to be kept by the centre and may be sampled by the external examiner or external quality assurer on their visit.
